Message from the President



When the #MeToo movement began in October 2017, it propelled a cultural shift for women around the world. As the hashtag spread virally in an attempt to demonstrate widespread prevalence of sexual assault and harassment, especially in the workplace, women – and some men – began sharing stories of harassment, assault, and inequality. Within 24 hours, #MeToo had been tweeted more than 500,000 times, and was used by more than 4.7 million people on Facebook.

Collective anger spurred, gathering strength with every retweet and story of injustice and abuse, quickly evolving into a revolution of refusal. A refusal to accept a culture of violence and abuse against women; gender-based power structures; inequity of any kind. As Nigerian author and feminist Chimamanda Ngozi Adichie says, "Gender as it functions today is a grave injustice. I am angry. We should all be angry. Anger has a

long history of bringing about positive change. But I am also hopeful, because I believe deeply in the ability of human beings to remake themselves for the better."

As part of our hope for a gender-equal future, including that of the leadership within our own Association, a resolution was passed at the January 2018 Provincial Executive meeting that set-in motion OECTA's inaugural Women's Leadership Conference. This decision was in direct response to pent up demand for a women-centric leadership opportunity within OECTA, especially in the #MeToo era. The purpose of this conference is to give women the opportunity to meet and share concerns and experiences that are particular to women in the workplace, and to build capacity in a positive, safe space.

As a woman holding the highest office in this Association, and after attending a series of women's symposia within the education sector this past year, I can't stress enough the importance of women supporting one another in a collective effort to educate and empower. OECTA's Fempower conference is about creating a positive space where women can do just that; where we can feel empowered to find and use our voice.

Thank you to my fellow female executive members, Barb Dobrowolski, Second Vice-president; and Ann Hawkins, Past President; together, we comprise the three female members of the 11-person Provincial Executive. Thank you to the female staff at our Provincial Office for designing and developing this first-ever conference from the ground up. Thank you to the many presenters, panelists, and delegates who will share their stories and experiences over the course of this conference.

As *Time* magazine Editor-in-Chief Edward Felsenthal said in honour of all of the "silence breakers" who have come forward and continue to come forward as part of the #MeToo movement, "It became a hashtag, a movement, a reckoning. But it began, as great social change nearly always does, with individual acts of courage."

Thank you all for your courage to be here today and for being a part of our own Fempower movement.

Message from the Conference Organizer

The year was 1989. I don't remember the joke, but I certainly remember the punchline, "Tune in Tokyo." A senior colleague, a man I had worked with for only a few months, reached out and touched my chest pretending he was turning radio dials. He got such a great laugh (from me as well) that he told the joke again during afternoon recess and he repeated the "tuning."

It wasn't okay!

It was my first year of teaching, my first staff room. I was young, naïve, and very determined to fit in and be a good sport. Back then there was no workplace harassment policy. Heck, we were still smoking in the staff room. We didn't call this kind of behaviour sexual harassment, we just called it life.



Fast forward almost 30 years and things are very different – or at least so I thought. While that kind of horseplay would not be considered acceptable (let alone funny) today, after watching the media circus surrounding the Supreme Court nomination hearings for Brett Kavanaugh in the United States, I am not so certain we have really progressed all that much. An article in the *Globe and Mail*, penned by Dr. Samantha Nutt, summed up what I and so many others felt in the aftermath of Kavanaugh's confirmation:

As girls we learn that:

To have opinions is to be angry;

To be angry is to be unattractive;

To be smart is to be threatening;

To speak up is to be shut down;

To have confidence is to be demeaned;

To have strength is to be intimidated;

To be difficult is to be lonely;

To be ambitious is to be obnoxious;

To tell the truth is to be accused of lying;

To have expertise is to be dismissed.

I hadn't spent much time thinking about the behaviours that I have tolerated over the course of my 52 years of life, but I am acutely aware! I don't know a single woman who has not experienced some form of sexual harassment or been subjected to inappropriate behaviour at some point in her life. This is an unacceptable reality.

And it is not okay.

It is time for this conference. It is time for us to talk to each other. We cannot build alliances with our brothers until we have figured out who we are and what we need to thrive in positions of leadership. We need to have the discussion about what we have to do to support one another. We need to have many conversations, starting here, but not ending here. And some of them will be very difficult.

We have 24 hours together and the Provincial Office staff and the members of the Status of Women Committee have put their collective hearts and souls into making sure that every minute of this conference provides us with an opportunity for reflection and growth. This will be an enlightening, educational, soul-filling journey into empowerment. YOUR empowerment – OUR empowerment.

I hope you enjoy this conference as much as we have enjoyed bringing it to you. And I challenge you to make the most of your time at this conference; to think differently and to get out of your comfort zone. Use your time here to meet someone new, to share your truth, to open your mind to new ideas, and to renew your strength, your courage and your faith.

Then take what you learn and pay it forward to another fabulous woman.

I dedicate my contributions to this conference to my magnificent step-daughter, Talia. It's like yesterday that she was wrapped around my waist clinging to me as I brushed my teeth. Now she towers over me and strides confidently through the halls of Guelph University. I remain cautiously optimistic about her future. May her journey be just a little bit kinder than my own.

Rosanna Arduini, Chief Financial Officer, OECTA Provincial Office

Rosanna is immensely grateful for the teachers who impacted her life growing up. In fact, she became a chartered professional accountant (CPA) because her Grade 12 teacher said she could do it and encouraged her to pursue that career path. She followed his advice by getting her Bachelor of Commerce from the University of Toronto, and then her CPA designation. She has not looked back.

Today, Rosanna has more than 30 years of experience behind her, in many different industries. She is currently the Chief Financial Officer at the Ontario English Catholic Teachers' Association, having previously held the position of Vice-President Finance and Comptroller at Nobel Biocare Canada Inc. Since joining OECTA, she has given many workshops on financial literacy to unit presidents and local treasurers, converted all OECTA units to one accounting platform, and become the Association's own internal unit auditor. Rosanna believes in paying forward her knowledge and experience; she has mentored four of her department members in the successful attainment of their own CPA designations.

Marie Clarke Walker, Secretary-Treasurer, Canadian Labour Congress
Marie started her career working in a home for the elderly, later with adults and children with
developmental disabilities, as a counsellor and family-support worker in Toronto, and once again at
the school board as an early childhood educator working with children with disabilities.

She rose rapidly through the ranks of the Canadian Union of Public Employees (CUPE), eventually becoming CUPE Ontario's Equity Vice-President and her union's first-ever National Diversity Vice-President. Marie made history in 2002 when she was elected as the first racialized woman, and the youngest person ever, to be elected to the position of Executive Vice-President of the Canadian Labour Congress (CLC). She served in that position for five terms before once again making history in May 2017, being elected the first-ever racialized woman to serve as CLC Secretary-Treasurer.

Marie is the mother of two sons and a mentor/femtor to many. She has served as a board member for a variety of organizations, including the Canadian Peace Alliance, the Canadian Centre for Policy Alternatives, Adventure Place, the Scarborough National Malvern Soccer Club and Scarborough Basketball Association, Julliette's Place, a shelter for abused women and children, the Canadian Centre for Occupational Health and Safety, and as an executive member of the Coalition of Black Trade Unionists.

Her passion is just as fervent now as it was when she first became involved in social movements. She continues to fight injustice everywhere, and looks forward to the day when Canada is truly a country that celebrates and respects equally all of its diverse and vibrant communities.



Carley Desjardins, Communications Specialist/Writer, Administration Department, OECTA Provincial Office

Carley is a communications specialist with a Master of Professional Communication degree, and a background in branding, communication strategy, leadership and crisis communications. After beginning her career at OECTA on the same day as her last undergraduate exam, Carley pursued every administrative position possible, while attaining her editing certification in the evenings, interning remotely for a Fortune 200 company out of Boston, and working voluntarily for various media publications. Carley went on to be the youngest Associate Director and eventually Director at Advocis, The Financial Advisors Association of Canada, where she was responsible for matters related to policy, governance, marketing, and communications of the organization's designation-granting wing, before returning to OECTA as a member of the senior resource staff in 2014.

In her current role at OECTA, Carley is responsible for all messaging from the President's office; she is also the lead on the 75th anniversary project. With more than a decade of experience working in various communications capacities, and now the mother of two young boys, Carley is an advocate for working mothers and the recognition that women with children are an asset to the workforce.

Michelle Despault, Director of Communications, OECTA Provincial Office Mom, professional, entrepreneur, athlete, and lover of life and chocolate. This is Michelle in a nutshell.

Michelle is currently the Director of Communications at the Provincial Office. Prior to joining the Association, she was the Director of Communications for the Minister of Education. Michelle holds a Master of Arts in international relations and foreign policy, and worked in a variety of government ministries before finding her home in the education portfolio, where she has spent the past 15 years of her career.

Michelle is a lifelong unionist and public servant. She took her first union job at the age of 16 and has since been a member of four different unions. Throughout her career, she has sought out opportunities that enable her to contribute meaningfully to the improvement of people's lives. Her passion is sharing her hard earned knowledge and insights with others, hoping to make a difference in their experience of life. To this end, she authors the Insight column in each issue of *Catholic Teacher* magazine.



By far, Michelle's most important and proudest role is that of mom to her four-year-old son, Liam. More than any other professional role, it is her role as mom that has pushed her beyond what she knew she was capable of, forcing her to get comfortable with being uncomfortable and surrender to the journey that is life.

Rev. Dr. Cheri DiNovo, United Church of Canada Minister and former MPP

As Member of Provincial Parliament for Parkdale High Park for more than 11 years, Cheri passed more Private Member Bills than anyone in Ontario's history, and more pro-LGBTQ legislation than anyone in Canadian history. Among her achievements: including gender identity and expression in the Ontario Human Rights Code; advocating for trans rights; banning conversion therapy for youth; championing parental equity for LGBTQ parents; and the Trans Day of Remembrance.

She is the recipient of numerous awards, including the Lambda Literary Award for her book Qu(e) erying Evangelism. Other awards include the Diamond Jubilee award, Ukraine's Medal of Honour, and awards from Bnai Brith, Tibetan, Inspire, Rainbow Health, PFLAG, the Canadian Psychological Association, and others.

She performed the first legalized same sex marriage in North America in 2001, and in 1971 was the only woman to sign on to "We Demand," Canada's first call for gay rights.

Currently she is the Minister at Trinity St. Paul's Centre for Faith, Justice and the Arts.





Barb Dobrowolski, Second Vice-President, OECTA Provincial Executive
After finishing two degrees, one in biochemistry nutrition and another in English, Barb Dobrowolski went on to teachers' college, where she finally found her calling – as a Catholic teacher.

In her early years as an elementary teacher, witnessing hard-working colleagues being maltreated by school board administration, Barb felt compelled to advocate on behalf of her colleagues. She became involved in OECTA in her first year of teaching, on a work-to-rule during the Rae Days. She was asked to chair the Communications Committee and she never looked back, becoming heavily involved in the Eastern Unit and eventually as a member of the Provincial Executive.

Barb has been a tremendous advocate for women's rights since the beginning of her career. She currently serves on the Ontario Federation of Labour Women's Committee, and as the Provincial Executive liaison to the OECTA Status of Women Committee.

Tesa Fiddler, Indigenous Education Resource Teacher, Thunder Bay Catholic District School Board

Tesa has been involved with Indigenous education for nearly 20 years. She is committed to bridging families and schools. Her work has included supporting families directly as well as providing teacher capacity-building opportunities through co-teaching and professional development workshops. Tesa's graduate studies focused on supporting Indigenous student success by creating culturally responsive and relevant learning environments.

More recently, Tesa has been exploring how Indigenous education correlates to social justice, antiracist, and equity education. Addressing equity issues or racism specific to Indigenous people in schools and communities requires learning about topics that might seem difficult for some, such as the Indigenous residential school system.





Ann Hawkins, Past President, OECTA Provincial Executive

Ann has been a Catholic teacher since 1975, most recently teaching social science. "Teaching is the best job in the world," she says. "I got into my first classroom and figured, 'Why would anybody want to do anything else other than this?"

Shortly after her teaching career began, Ann became involved in the fight for Bill 100, which finally laid the groundwork for teachers in Ontario to have the legal right to strike. Her participation further increased in the 1990s, as teachers fought the anti-teacher, anti-union agenda of Mike Harris.

Ann has served the Association in a number of different ways, including working her way up the Provincial Executive, from Councillor to President. She is passionate about promoting human rights and women's issues, and has represented OECTA at the United Nations Commission on the Status of Women, the Canadian Teachers' Federation Advisory Commission on Women's Issues, the Canadian Labour Congress Women's Committee, and the Ontario Federation of Labour Women's Leadership Summit.



Shannon Hogan, Staff Officer, Counselling and Member Services Department, OECTA Provincial Office

For more than 30 years, Shannon has contributed to Catholic education in many capacities: as a secondary teacher in English and theology for 18 years, head of a theology department, Chair of the Religious Education Department Heads Association, school chaplain, religious education consultant, Adult Faith Animator for the Toronto Catholic District School Board, and professor in the Pre-service Religious Education Program at York University. As a Staff Officer in the Professional Development department at the Provincial Office, she had oversight over the religious education Additional Qualifications (AQ) courses, and eventually over all AQ courses offered by the Association across the province. She is currently a Staff Officer in the Counselling and Member Services department.

Shannon has been a contributing writer and reviewer for publications of the Institute for Catholic Education. She was lead writer of the provincially mandated renewal of Roman Catholic religious education courses, and for the World Religions course in the secular system. She has also been a

contributing writer for the Canadian Centre for Policy Alternatives.

Shannon has a specialist in religious education and guidance counselling. She has primary/junior-intermediate/senior qualifications, and her Principal Qualification designation. She has advanced degrees in both theology and counselling psychology, and has completed the requisites for her doctoral work in theology.

Carla Hosseini-Tonekaboni, Staff Officer, Bargaining and Contract Services Department, OECTA Provincial Office

Carla began her teaching career in 1987, teaching secondary French with the Halton Catholic District School Board. She became actively involved with OECTA in 1993 as a Councillor on the local unit executive and served as Grievance Officer from 2007 to 2013, after which she was hired to the Provincial Office as a Staff Officer in the Bargaining and Contract Services department.

As a member of the BCS department, she assists local units in developing initial proposals and bargaining local collective agreement terms, and she serves as a resource to the Provincial Executive during the provincial bargaining process. She also provides support to local units on all matters related to grievances. Carla has delivered workshops on collective bargaining for the OECTA Leadership Training Program, and a workshop titled, "Learning to Say 'No' - Knowing Your Rights and Responsibilities," for the Beginning Teachers Conference.

Kate's practice covers a wide range of areas including labour arbitration, judicial reviews and appeals, court injunctions, advice regarding strikes and lockouts, labour board proceedings, professional regulation and discipline, education law and health law, inquests, civil litigation, and human rights matters.

Kate has successfully argued two leading Supreme Court of Canada (SCC) cases. She was counsel in the ground-breaking discrimination case known as *Meiorin*, or the "female firefighter case," where the SCC accepted her argument and used it to establish the new test for discrimination.

Kate is well known for her work in human rights. She is counsel on the leading case dealing with systemic human rights remedies, *McKinnon v. the Ministry of Corrections*, which has been upheld by the Court of Appeal.

Over the last two decades, Kate has represented many professionals, including nurses, midwives, and other health professionals governed by the *Regulated Health Professions Act*. She has also represented teachers in discipline matters, arbitrations, interest arbitrations, inquests, injunctions, human rights proceedings, civil litigation, and judicial reviews and appeals at all levels.

Farrah Khan, Consent Culture Educator and Activist

Farrah Khan has spent two decades raising awareness about the intersections of gender-based violence and equity through art creation, education, and advocacy. Her innovative research, passion, and sense of humour create an engaging dialogue that highlights pleasure and fun while addressing the realities of gender-based violence prevention.

Recognized as a leader in her field, she has been appointed to the G7 Gender Equality Council, the Government of Canada's Advisory Council on the Strategy to Prevent and Address Gender Based Violence, and was and is co-chair of Ontario's Roundtable on Violence Against Women. Farrah is also host of the upcoming podcast, "Pleasure Principle," and works with grassroots feminist groups including femifesto.

Farrah holds a Master of Social Work from the University of Toronto and is the Sexual Violence Support and Education Co-ordinator at Ryerson University. She regularly contributes her expertise in addressing violence against women to national media, including CBC's "The National," the *Toronto Star*, and the *Globe and Mail*.
