

#### **EMPLOYEE LIFE AND HEALTH TRUST TRUSTEE - ALTERNATE**

(up to 3 alternate positions available)

The Ontario English Catholic Teachers' Association, representing 45,000 teachers in Ontario's publicly funded Catholic schools, invites applications for the position of **Trustee Alternates of the Employee Life and Health Trust (ELHT)**. This is a voluntary position with training, release time as required, and reimbursement of expenses provided by the Association. The successful applicants will begin required training for their duties within three (3) months of their appointment and be prepared to commence their term after completion of training, if called upon.

Trustee Alternates of the Employee Life and Health Trustee (ELHT) may be called upon to serve as Trustee **on very short notice,** should one of the sitting Trustees no longer able to serve in the role.

Trustees of the Employee Life and Health Trustee (ELHT) carry significant responsibilities for tens of thousands of members of the OECTA ELHT and their families. They make governance decisions, driven by actuarial, investment, legal, insurance or operational considerations. A Board of Trustee position generally requires knowledge of the benefits field, so the individual is comfortable with information received, and is confident enough in their understanding to accept or reject expert advice, ask probing questions, and make independent decisions.

Trustee Alternate candidates will also need to understand the fiduciary nature of the position, have some familiarity with actuarial or investment concepts and have the time required to devote to their duties should they be called upon to serve.

### Required qualifications include:

- 1. A member in good standing who is enrolled in the OECTA Employee Life and Health Trust Provincial Benefit Plan for the full length of term of office.
- 2. May be required to commit to attend board and committee meetings, as required, over a 3-year term, with possible reappointment to a subsequent 3-year term.
- 3. Employee Life and Health Trustee Alternate, shall:
  - undertake training and ongoing professional development
  - work in a collaborative fashion
  - · possess good problem-solving skills
  - meet all fiduciary objectives
  - meet confidentiality/privacy requirements
  - possess good conflict management skills
  - maintain solidarity in decisions of the Board.
- 4. Execution of an attestation concerning bankruptcy and competency.
- 5. Knowledge of and/or experience with employee benefit plan design and administration.

## The following qualifications would be an asset:

- 1. Knowledge of trust fund structure.
- 2. Knowledge of legal duties of trustees.
- 3. Association involvement.
- 4. Understanding of the ELHT governance structure, including the role of collective bargaining, the role of the OECTA, the role of the employers, the role of the ELHT Board of Trustees.
- 5. Ability to delegate to and monitor third party advisors and employees.
