Principal Duties and Responsibilities

- Provide advice, guidance, and representation of members for the Association:

- Conduct reviews of WSIB/disability claim files and provide legal opinions on WSIB claims, LTD policy matters, and return-to-work issues

- Represent the Association before the Human Rights Tribunal of Ontario (HRTO)
- Represent the Association in the grievance/arbitration process
- Conduct merit reviews of claim files

- Represent members of the Association in formal legal proceedings related to the denial of benefits
- Provide advice to the General Secretary, Deputy General Secretary, and Human Resources on administrative and personnel-related matters
- Contribute to policy development and support Accessibility, Inclusion, Diversity, and Equity (AIDE) initiatives across the Association
